1. Mayor Smith opened the public hearing on the Fiscal Year 2023 Budget Amendment. Hearing no oral or written comments, the hearing was closed.



4. Council Member Schleisman moved, Ashton seconded, to approve RES 321-23 supporting the City of Reinbeck to impose a 1% local option sales and service tax on the November 2023 Ballot. Ayes: Ashton, Brockman, Rego, Scafferi, Schleisman.
5. Council Member Scafferi moved, Brockman seconded, to approve RES 322-23 authorizing abandonment proceedings pursuant to Iowa Code Section 657A against real property located at 205 Wadeloup Street in the City of Beaman, Grundy County, Iowa, Ayes: Ashton, Brockman, Rego, Scafferi, Schleisman.
