BUSINESS

1. Jeff Kolb, Butler/Grundy Economic Development Director, announced that Peoples Savings Bank in Wellsburg has agreed to finance the Homes for Iowa program in Beaman. The Development Corp Board and Peoples Savings Bank will manage the project. An advisory committee of 2 council members, 2 development board members and 1 member from INRCOG will serve on this committee. Barry Brockman and Brandon Schleisman have agreed to serve as the City Council appointees. The committee will make day-to-day decisions and appoint subcontractors. Council member Brockman moved, Schleisman seconded, to deed the property, 209 Wadeloup, Beaman, IA, to the Butler/Grundy County Development Board pending a development agreement that will be drafted by city attorney Heather Pendergast. Ayes:

- 2. Council received and considered bids to remove asbestos and demolish 209 Main Street, Beaman. Council member Scafferi moved, Ashton seconded, to accept proposals contingent upon the city acquiring financing, from Advanced Environmental, 803 Ricker Street, Waterloo, in the amount of \$16,446.00 for asbestos removal, and also from Boulder Contracting, Grundy Center, in the amount \$82,000.00 for building demolition. Contract will be signed once financing is secured. Ayes: Scafferi, Ashton, Brockman, Rego, Schleisman.
- 3. Council member Scafferi moved, Brockman seconded, to adopt RES 2025-05 setting wages for FY2026. Ayes: Scafferi, Brockman, Ashton, Rego, Schleisman.
- 4. Council member Schleisman moved, Scafferi seconded, to approve the second reading of ORD 176, amending Chapter 55 Animal Protection and Control. Ayes: Schleisman, Scafferi, Ashton, Brockman, Rego.
- 5. Council member Brockman moved, seconded by Ashton, to enter into an agreement with Government Window for a Software as a Service agreement to allow the city to accept credit/debit cards with. Ayes: 5.
- 6. Under pickleball court update it was reported that Boulder had removed the building next to the tennis court and had started a concrete extension for new pickleball courts.
- 7. Nuisance Property Ordinance/Nuisance Properties:
 - a. Jason will check with KWD, LLC on the start date to clean up property at 104 Center Street.
 - .b. Mayor Smith will call for mosquito spraying services.
 - c. City Clerk was instructed to follow up on junk vehicles located at 207 Beckman.
