- 6. Economic Development no report.

BUSINESS

- 1. A public hearing was set for April 23, 2025, at 6 PM at the City Hall for the adoption of the FY206 budget.
- 2. Water meter recommendations were tabled until the next regular meeting.
- 3. Council member Rego moved, Schliesman seconded, to approve a contract with Ryan Ashton for 2025 mowing for the same amount as last years contract. Ayes: 4, Deb Ashton abstained due to conflict of interest.
- 4. No update for Homes for Iowa.
- 5. Council considered specification for cleaning out of 209 Main Street Jason Scafferi verbally went over some specifications that should be considered. Specifications not presented. Once ready, post the request for estimate at City Hall, Bank, Post Office. Jason said we need to look at funding. Mayor Smith mentioned the State Revolving Fund. Post request for estimate for 2 weeks. City would be responsible for dumpster tipping. Will probably put dumpster in the back. Motion to accept and post requirements for 2 weeks by Schleisman, second by Ashton. Ayes 4; Jason Scafferi abstained due to conflict of interest.
- 6. Nuisance Property Ordinance/Nuisance Properties: Fire chief Moeller said that the house located at 104 Center Street, Beaman, can be burned. This will be done as soon as practical. Mayor Smith asked that the Sheriff's department be notified of the date for the burning once set.
